- On July 21, 2015, 2,442 restricted shares of Mr. Welch's Company stock, granted February 26, 2013, vested. On July 21, 2015, Mr. Welch automatically surrendered 1,135 of the 2,442 newly-vested shares to the Company to satisfy the tax withholding obligation triggered upon the July 21st vesting. The automatic surrender of newly-vested shares is the Company's default process for paying tax withholding obligations triggered upon the vesting of restricted stock.
