The automatic surrender of newly-vested shares is the Company's default process for paying tax withholding obligations triggered upon the vesting of restricted stock.
- On February 23, 2017, 4,347 restricted shares of Ms. Fisher's Company stock, earned February 15, 2016, vested. On February 23, 2017, Ms. Fisher automatically surrendered 2,250 of the 4,347 newly-vested shares to the Company to satisfy the tax withholding obligation triggered upon the February 23rd vesting. The automatic surrender of newly-vested shares is the Company's default process for paying tax withholding obligations triggered upon the vesting of restricted stock.
